WARRANTY COVERAGE

LUX Panel Steel Siding is warranted to the original property owner by the manufacturer, Wayne Building Products Inc. (WBP). WBP warrants against the siding containing manufacturing defects which result in cracking, chipping, flaking, peeling or splitting as well as maintaining its film integrity for a period of 25 years Pro Rated following the original date of purchase. Additionally, WBP warrants that LUX products, after removal of foreign surface deposits will not chalk in excess of the No.8 rating ASTM-D-4214 as determined by the procedure outlined in ASTM-D-4214 and will not fade more than the Rating not > 5Δ Hunter Units @ 20 yrs. as determined by the procedure outlined in ASTM D2244 - Hunter Units (Florida Exposure @ 450 S) and based on the color measurements made on clean surfaces free of all dirt, chalk, oxidized film, oil, grease or other foreign contaminants; provided, however, that fading or color changes may not be uniform between surfaces not equally exposed, for the duration of the warranty. This warranty shall be valid only after the registration certificate is completely filled in by the original property owner(s), signed and mailed to WBP within thirty (30) days after completion of the installation of the LUX Products or purchase from the builder of your newly constructed home. All warranties are subject to the conditions, remedies, limitations and legal rights stated in this certificate. This warranty may be transferred to subsequent owners of the property to which the paneling is attached provided WBP receives written notice of transfer of title of the property within 90 days of the date of transfer of ownership. If you think your LUX paneling shows manufacturing defects during the warranty period, WBP, at its option, will refund the cost of material or replace the defective material. The warranty covers the cost of material and does not cover installation, labor or freight costs. Any costs and expenses beyond WBP's liability shall be paid by the property owners. If you think your LUX paneling contains manufacturing defects write to Wayne Building Products Inc., 12603 123 Street, Edmonton, Alberta T5L 0H9. Attention: LUX Panel Warranty Program by registered mail. Include date of installation, name of installer, product and color installed, including original sales agreement. WBP must be given the opportunity for inspection of the site prior to any remedial action being offered or taken. If it is determined by WBP, that upon inspection a claim for defective finish on product is valid, the remedy for the claim shall be at the sole discretion of WBP's option to replace the defective Lux panel product or refund the purchaser the price paid for the Lux product. WBP reserves the right to discontinue or make changes in its LUX Paneling. If your paneling is not available and WBP determines replacing the defective siding is the best option. WBP shall have the right to substitute paneling which it considers of equal quality and price. This warranty does not cover degraded panels caused by abrasion, chemical cleaners or damage caused by other products, steel shavings or minute particles from sawing sparks that come into contact with the painted finish, improper storage or moisture entrapment in bundles during transit or storage. Also damage resulting from abnormal atmospheric conditions, this includes, but is not limited to: Hail, exposure to salt, high pressure water spray, corrosive or harmful chemicals or airborne contaminants or LUX products that have not been maintained, used or installed in accordance with published recommendations of WBP, and accepted good trade practices. Slight color variations between separate orders are considered normal and not covered by this warranty. The express warranty stated herein is the exclusive warranty, applicable to LUX Panel metal products. WBP makes no guarantees either expressed or implied beyond the face hereof and without limitation, all warranties as to the fitness and or merchantability are restricted to the express terms hereof. The total liability of WBP is expressly limited to the purchase of the LUX Panel metal products. WBP reserves the right to terminate or modify this warranty, except with the respect to any order which it has already accepted upon the giving of written notice thereof.
